**NOTICE TO ALL MID-CANADA MOD CENTER  
AND AVIONICS DESIGN SERVICES VISITORS**

Considering the coronavirus outbreak's ongoing global spread and in order to protect the health of our employees and customers at our facilities, only authorized business-critical visitors will be permitted at any MC<sup>2</sup> or ADS facility. We will now require additional screening of all business-critical visitors prior to entry into any MC<sup>2</sup> or ADS facility.

Effective immediately, all visitors entering MC<sup>2</sup> or ADS facilities are required to complete the MC<sup>2</sup> and ADS Visitor Health Screening Questionnaire. If any questions are answered "yes," access will be denied, and the visitor will be asked to reschedule their meeting or make other arrangements.

**If you have traveled to any country outside Canada, had close contact with someone who had either been diagnosed with COVID-19 or exhibits symptoms of COVID-19, or other cold or flu-like symptoms within the last 14 days, access will be denied.**

People with COVID-19 have had a wide range of symptoms reported. We recommended that you use the Health Canada or Provincial [Self-Assessment Tool](https://ca.thrive.health/covid19/en) (<https://ca.thrive.health/covid19/en>).

Thank you for your patience with these health and safety measures as we continue to address this outbreak together.

The safety of our employees, customers, supply partners, families, and visitors remain MC<sup>2</sup>'s and ADS' overriding priority. As the coronavirus disease (COVID-19) outbreak continues to evolve, MC<sup>2</sup> and ADS is monitoring the situation and will periodically update company policies based on current recommendations from Federal authorities, and reflect the most current available recommendations communicated by health authorities such as the CDC and WHO.

Only business critical visitors are permitted at any MC<sup>2</sup> or ADS facility at this time. To prevent the spread of COVID-19 and reduce the potential risk of exposure to our workforce and visitors, we are conducting a simple screening questionnaire. Your participation is important to help us take precautionary measures to protect you and everyone in this building. Thank you for your time.
